Aquatic Plant Control

- Progressive AE did 4 lake weed surveys on May 2, June 1, July 2, and August 13
- Clarke Aquatic Services did 4 herbicide applications shortly after the surveys
- We spent \$127, 000 vs. \$120,000 budgeted
- Milfoil and coontail north of the Findley Road bridge proved difficult to control.

Aquatic Plant Control

- Progressive provided an annual activity summary report earlier this month which can be found on our laketemplene.org website
- Our lake has an abundance of plant life with Eurasian milfoil & starry stonewort the targeted plants, both non-native species

Aquatic Plant Control

- In 2019 the Harvester will be utilized earlier in the season
- DEQ regulations do not permit herbicide weed control further than 300 feet from shore past June 15th
- Starry Stonewort was not an issue in 2018

- The Lake Templene Improvement Board contracts with Progressive AE & Clarke Aquatic Services
- The LTIB advisory committee works on a tactical basis with recommendations







Bottomland removal plans for 2019

East Bay will have one aeration + bio-augmentation system removed. Likely will add bio-augmentation to a portion of Hickory Hills 2 near the Norris and Splitt homes

Bottomland removal plans for 2019

- Will be doing water quality sampling spring, summer, fall for a new permit application process.
- Changes in DEQ permitting require data gathering prior to submitting paperwork.


Bottomland removal plans for 2019

- Depending on 2018 results we are looking at adding aeration to 2-3 sites
- Currently we have 3 sites with bioaugmentation only on Findley Rd, near Crystal Beach and on Butternut east of the Boyce home

Fishery Enhancement for Spring 2019

- 2000 Yellow perch size 4-7" at \$1,940/1000 plus \$150 freight
- 4,000 Black crappie size 3-4" at \$2,750.
- 1,600 Hybrid bluegill size 4-6" at \$3,008 plus freight
- Total cost to restock Lake Templene will be \$10,000

SAD FUNDING FOR 2019

- The Lake Templene Improvement budget for 2019 is \$318,533
 - Aquatic Plant Control
 - Bottomland Reduction
 - Fishery Ehancement

- SAD FUNDING FOR 2019
- The Lake Templene Improvement SAD assessments on the winter tax bill will be
 - \$780 for a developed lakefront lot
 - \$390 for a undeveloped lakefront lot
 - \$4,200 for the Island Hills Golf .Club

Shoreline Improvements

- Pheasant Pointe Drive shoreline leading to the Big House is being restored this month with fabric underlayment and stone. Erosion has been occurring for years
- Walter's Island near Ridgewoods 2 will be restored next spring when water returns to normal pool level. Have permit, barge, and workers

- Development Plans for South Beach
- The Island Hills open space preservation ordinance was approved in October by Nottawa Twp.
- The plans for development being considered call for 8 single family homes with lakefront lots.
- The Fall Lake Templene newsletter contains an article on the current status





- Snow Plowing new contract
- Alpine Construction was the low bidder of five contractors who submitted quotes
- The contract is for 2018-2023, a 5 year firm price basis
- The base price will be \$27,000 plus extra costs for sand, heavy equipment if needed





Road Repaving Project Results

- We had asked for \$500 for developed lots and \$250 for undeveloped lots each year for a 5 year period
- None of the 11 subdivisions around the lake supported the petition drive to the required 60% acceptance
- The overall average was 32%

Next steps to repair the roads

- We have cul-de-sacs that need to be made fire truck friendly-primarily cutting out obstructions. An example would be Lakeview Circle in Hickory Hills 2
- There are a very few road edges that allow rainwater to run into property owner garages. They are in the road right of way Lake Templene Property Owners Association

Next steps to repair the roads

- Double chip & seal with fog coat
- This is what St. Joseph County road commission utilizes. Findley Road is an example
- Lasts 5-7 years on a normal public road





Next steps to repair the roads

- 10.6 miles times \$18,000 = \$190,000
- Establish a 3 year sinking fund at \$200 for a developed lot, \$100 for an undeveloped lot
- This would give us \$216,000





Next steps to repair the roads

- Billing would be part of the annual dues billing. No SAD would be established
- Funds would be kept in a separate account code within our accounting
- The LTPOA board would have to approve the sinking fund route

July 7th Fireworks Display

- Thanks to the shore captains for their work on obtaining the \$15,000 cost
- This was the fifth year for Flashing Thunder to light up the sky





Mowing of common grounds & vacant lots

- We have a 3 year contract with Custom Lawn Care 2017-2019
- 10 mowings per season cost \$16,000
- We schedule mowings every 2 weeks beginning early May
- Vacant lots are \$200.

Lake Safety

- Have ordered new buoys for spring 2019
- Installed more lights on buoys
- Working with the sheriff's department to have their time on the lake focused on boater safety issues
- If you see an unsafe activity report it to the sheriff's department 269-467-9045
